\$750 Million Acquisition Financing of Ascenty Group

Ascenty is one of Latin America's largest data center providers with 14 data centers in operation and / or under construction. The acquisition was one of the world's largest data center acquisitions in 2018, and is expected to establish Digital Realty as the leading data center provider in Latin America.

The acquisition financing involved a complex multijurisdiction structure that involved a corporate restructuring of the Ascenty Group and the satisfaction of a number of condition precedentes in different countries, including the creation of security over Ascentry Group's assetes and Digital Realty assets both in Brazil and in the Unites States.
